PrintPost Ltd. has created this privacy statement ("Privacy Policy") in order to demonstrate our firm commitment to your privacy online. The following discloses our information gathering and dissemination practices for the PrintPost web site.

#### Your IP Address

We use your IP address to help diagnose problems with our server, and to administer our web site. Your IP address is not used by PrintPost to help identify you and to gather broad demographic information about you.

### What Cookies are and what they do

A cookie is a small text file that is saved to the hard drive of your computer when you use a website. Our website use both session and persistent cookies. Session cookies are transferred to your computer only for the duration of your visit to a website. Session cookies help you to move round a website faster and allow's the user to give you information relevant to the services you require. These cookies automatically expire when you leave a website or shut down your browser. Persistent cookies are cookies that stay on your computer permanently until you manually delete them.

We use the information to compile reports and to help us improve the site. The cookies collect information in an anonymous form, including the number of visitors to the site, where visitors have come from geographically, and the pages they have visited, the devices and browsers the visitor is using.
APISID, CONSENT, HSID, NID, SID, SIDCC	Google Maps	These cookies are used by Google to store user preferences and information when viewing pages with Google maps on them
